Girls Inc. of Greater Philadelphia & Southern New Jersey has been serving the region since 1961, beginning as Teen Aid before becoming an independent affiliate of the national organization, Girls Inc., in 2002.

Girls Inc. uses a whole-girl approach to inspire all girls and young women to be strong, smart, and bold.

Girls learn to value themselves, take positive risks, and develop their inherent strengths through a combination of research-based programs, mentoring relationships, and a pro-girl environment.

Our programs focus on healthy decision making, academic enrichment, life skills instruction, and career exploration. Through these research-based programs, our participants gain the skills to navigate gender, economic, and social barriers and grow into healthy, educated, and independent young women.

Letter from the CEO

This year I have the privilege of reflecting on 10 years at the helm of this important organization. It is important because the work changes the trajectory of women's lives and transforms communities. The obstacles that girls and young women face have not improved during this past decade and in some ways, have gotten worse. Access to healthcare has suffered. Social media has made it more difficult to be an adolescent. The pay gap is real and representation in leadership roles continues to lag. Many of the conversations in boardrooms and government offices that created so much hope in the fight for equity have been redirected to new concerns. The differences in the ways in which males and females experience violence and discrimination are real but are still too often treated as the same.

Despite setbacks, I am filled with hope, enthusiasm, and gratitude. I am hopeful because this generation of young women has big dreams and the skills to achieve those dreams. I am enthusiastic because this generation of young girls are being introduced to possibilities that I never would have imagined at their age and with us, they are acquiring the skills and confidence to pursue those possibilities. They have learned to navigate historic barriers and are prepared to take on the new ones.

We are at a crossroads, where possessing confidence, self-advocacy and high expectations has never been more important. If you have met the girls and young women in our programs, you know what I am talking about. They understand that they are the most important determinant in creating their own bright futures. We help them acquire the critical tools to make healthy decisions about their bodies, achieve academic excellence and advocate for themselves and their communities as they pursue leadership careers, often in fields historically closed to women.

I am full of gratitude to our corporate partners, volunteers and our many nonprofit and government supporters who understand that the issues girls and young women face are unique and complicated and deserve the targeted proven solutions that we deliver. To our board of directors led by Lori Garber and our associate advisory board, thank you for your partnership and counsel.

I am so grateful to the parents and guardians who entrust us to help prepare their daughters for exciting futures. But I am most grateful to our participants who could be doing many other things during their free time but choose to be with us, engaging with like-minded peers in safe, fun, productive spaces. They are committed to achieving a future that is meaningful, and we are committed to helping them achieve their goals. To these young women, thank you in advance for helping to create a more equitable world where women's voices are front and center, because when women succeed, we all do better. Your ambition will lift us all.

I feel good about the past 10 years of accomplishments at Girls Inc. We have dramatically increased the number of girls we serve, their engagement with us, our geographic reach and our financial sustainability. Our outcomes are excellent. I am most proud of the staff culture we have created. We walk the talk, we have increased salaries, benefits, professional development and career opportunities. I wish we could have done more, but our industry suffers from the same misalignment of contribution and pay as other critical social service and educational occupations. We acknowledge that the day job is only a part of everything adults need and want to do and have made flexibility a critical component of our workplace. The result is worth noting in this post-pandemic environment where longevity in employment seems to have lost meaning. Our staff retention has been strong. Our participants and their families benefit from experienced, dedicated professionals and consistent mentorship. Thank you to the Girls Inc. staff who make the magic happen every day. Working with you has been both an honor and a pleasure.

I will be leaving Girls Inc. at the end of this year. I want to thank the staff, board, participants, families and partners for trusting me with this awesome responsibility. I am excited to see where this important organization goes next.

Strong

Friendly PEERsuasion builds girls' skills for resisting pressure to use harmful substances such as alcohol, tobacco, household chemicals, and other drugs.

Healthy Sexuality assists girls in understanding and embracing sexuality with a positive, empowered approach that is built on a foundation of accurate information, cultural sensitivity, and values of inclusiveness and respect.

Sporting Chance builds movement and athletic skills, cooperative and competitive spirit, health awareness, and interest in all sports as girls explore the benefits of an active lifestyle.

Media Literacy encourages girls to think critically about media messages and fosters their awareness of the power of the media and its effects on girls.

Bold

Project BOLD strengthens girls' abilities to lead safer lives by developing strategies for self-defense, seeking out caring adults to help with personal violence, and advocating on violence issues.

Leadership and Community Action

builds leadership skills and creates lasting social change by partnering girls and women in community action projects chosen by girls.

Career Exploration introduces girls to a broad range of career options and professionals in those careers.

Smart

Early Literacy initiative is designed to help increase literacy rates, testing scores, and foster a lifelong love of reading for participants in grades K-3.

Economic Literacy introduces girls to basic economic and financial concepts, including money management, investments, and global economics.

Operation SMART builds girls' skills and interest in science, technology, engineering, and mathematics.



A Decade of Growth

Girls Inc. Philly has two Out-of-School Time Programs

Ambassadors Club: A high school leadership and post-secondary readiness program to support girls as they grow into healthy, educated, independent women. Ambassadors explore post-secondary academics and careers, develop personal goals, and participate in career exploration opportunities.

STEM Gems: STEM-focused program to explore, ask questions, persist, and solve problems through hands-on activities. Girls learn to view STEM careers as exciting and filled with new opportunities.







